STIPULATION AND CONSENT TO ENTRY OF ORDER OF PROHIBITION

WHEREAS, the Office of Thrift Supervision ("OTS"), based upon information derived from the exercise of its regulatory responsibilities, has informed ANAMARIA PEDRAZA, a former employee of The Dime Savings Bank of New York (OTS No. 7837, the "Institution") that the OTS is of the opinion that grounds exist to initiate administrative prohibition proceedings against ANAMARIA PEDRAZA pursuant to Section 8(e) of the Federal Deposit Insurance Act ("FDIA"), 12 U.S.C. § 1818(e);¹ and

WHEREAS, ANAMARIA PEDRAZA desires to cooperate with the OTS to avoid the time and expense of such administrative litigation and, without admitting or denying that such grounds exist, or the Findings of Fact or opinions and conclusions of the OTS, except as to Jurisdiction (paragraph 1, below), which is admitted, hereby stipulates and agrees to the following:

1. Jurisdiction.

(a) The Dime, at all times relevant hereto, was a "savings association" within the meaning of 12 U.S.C. § 1813(b) and 12 U.S.C. § 1462(4). Accordingly, it is an "insured depository institution" as that term is defined in 12 U.S.C. § 1813(c).

(b) ANAMARIA PEDRAZA, as a former employee of the Institution, is deemed to be an "institution affiliated party" as that term is defined in 12 U.S.C. § 1813(u), having served in such

capacity within six (6) years of the date hereof. See 12 U.S.C. § 1818(i)(3).

(c) Pursuant to 12 U.S.C. § 1813(q), the OTS is the "appropriate Federal banking agency" with jurisdiction to maintain enforcement proceedings against such a savings association or its institution-affiliated parties. Therefore, ANAMARIA PEDRAZA is subject to the authority of the OTS to initiate and maintain prohibition proceedings against her pursuant to 12 U.S.C. § 1818(e).

2. OTS Findings of Fact. The OTS finds that on January 20, 1999 ANAMARIA PEDRAZA, without authorization, misapplied \$25,000 of the funds of the Institution to her own use. This occurred when she prepared a report showing she cashed a \$25,000 U. S. Government check and on the same day she disbursed another check for \$25,000 made payable to Beth Frisna. Further, you admitted this misappropriation in a signed hand written statement to Dime Security Officer Anthony Santangelo on January 21, 1999. In this statement, you admit destroying the \$25,000 check. As a result of the foregoing, ANAMARIA PEDRAZA(1) engaged in a violation of law or breached her fiduciary duty of honesty to the Institution; and (2) the Institution suffered a financial loss or ANAMARIA PEDRAZA received a financial gain or other benefit; and (3) the violation of law or breach of fiduciary duty demonstrates willful and/or continuing disregard ANAMARIA PEDRAZA for the safety and soundness of the Institution.

3. Consent. ANAMARIA PEDRAZA consents to the issuance by the OTS of the accompanying Order of Prohibition ("Order"). ANAMARIA PEDRAZA further agrees to comply with the terms of the Order upon issuance and stipulates that the Order complies with all requirements of law.

4. Finality. The Order is issued by the OTS pursuant to 12 U.S.C. § 1818(e). Upon its issuance by the OTS, the Order shall be a final order, effective and fully enforceable by the OTS under the provisions of 12 U.S.C. § 1818(i).

5. Waivers. ANAMARIA PEDRAZA, waives the following:

- (i) the right to be served with a written notice of the OTS's charges against her (*see, e.g.*, 12 U.S.C. § 1818(e));
- (ii) the right to an administrative hearing of the OTS's charges against her (*see, e.g.*, 12 U.S.C. §§ 1818(e) and 1818(h));
- (iii) the right to seek judicial review of the Order, including, without limitation, any such right provided by 12 U.S.C. § 1818(h), or otherwise to challenge the validity of the Order; and
- (iv) any and all claims against the OTS, including its employees and agents, and any other governmental entity for the award of fees, costs or expenses related to this OTS enforcement matter and/or the Order, whether arising under common law, the Equal Access to Justice Act, 5 U.S.C. § 504, or 28 U.S.C. § 2412.

6. Scope of Release: Other Government Actions Not Affected.

(a) ANAMARIA PEDRAZA acknowledges and agrees that her consent to the entry of the Order is for the purpose of resolving this administrative prohibition action only, and does not release, discharge, compromise, settle, dismiss, resolve, or in any way affect any actions, charges against, or liability of ANAMARIA PEDRAZA that arise pursuant to this action or otherwise, and that may be or have been brought by any other governmental entity other than the OTS.

(b) By signing this Stipulation and Consent, ANAMARIA PEDRAZA agrees that she will not assert this administrative proceeding, her consent to the entry of the Order, and/or the entry of the Order as the basis for a claim of double jeopardy in any pending or future proceeding brought by the United States Department of Justice or any other federal or state governmental entity.

7. Indemnification Limitations. ANAMARIA PEDRAZA represents that she has not received, directly or indirectly, any sums from the Institution for the purpose of indemnifying or reimbursing her for any expenses incurred by her relating to the issuance of the Order. ANAMARIA PEDRAZA shall not cause or permit the Institution (or any successor institution, holding company, subsidiary, or service corporation thereof) to incur, directly or indirectly, any



expense for any legal or other professional expenses incurred relative to the negotiation and issuance of the Order. ANAMARIA PEDRAZA also shall not obtain any indemnification (or other reimbursement) from the Institution (or any successor institution, holding company, subsidiary, or service corporation thereof) with respect to such amounts. Any such payments received by or on behalf of ANAMARIA PEDRAZA in connection with this matter shall be promptly returned to the Institution (or any successor institution, holding company, subsidiary or service corporation thereof).

8. Miscellaneous.

(a) The construction and validity of this Stipulation and the Order shall be governed by the laws of the United States of America;

(b) All references to the OTS in this Stipulation and the Order shall also mean any of the OTS's predecessors, successors, and assigns;

(c) The section and paragraph headings in this Stipulation and the Order are for convenience only, and such headings shall not affect the interpretation of this Stipulation or the Order;

(d) The terms of this Stipulation and the Order represent the final written agreement of the parties with respect to the subject matters hereof, and constitute the sole agreement of the parties with respect to such subject matters; and

(e) This Stipulation and the Order shall remain in effect until terminated, modified, or suspended in writing by the OTS, acting through its Director, Regional Director, or other authorized representative.

ORDER OF PROHIBITION

WHEREAS, ANAMARIA PEDRAZA has executed a Stipulation and Consent to Entry of an Order of Prohibition ("Stipulation"); and

WHEREAS, ANAMARIA PEDRAZA by her execution of the Stipulation, has consented and agreed to the issuance of this Order of Prohibition ("Order") by the Office of Thrift Supervision ("OTS"), pursuant to Section 8(e) of the Federal Deposit Insurance Act, 12 U.S.C. § 1818(e);¹ and

WHEREAS, the Director of the OTS has delegated to the Regional Directors of the OTS the authority to issue orders, pursuant to provisions of 12 U.S.C. § 1818, where the institution-affiliated party who is the subject to the order has consented to its issuance.

NOW THEREFORE, IT IS ORDERED that:

1. ANAMARIA PEDRAZA is prohibited from further participation, in any manner, in the conduct of the affairs of The Dime Savings bank of new York, Uniondale, NY (OTS Docket No. 7837), and any successor institution, holding company, subsidiary, and/or service corporation thereof.

2. ANAMARIA PEDRAZA is and shall be subject to the statutory prohibitions provided by 12 U.S.C. § 1818(e), and, except upon the prior written consent of the OTS (acting

through its Director or an authorized representative thereof) and any other "appropriate Federal financial institutions regulatory agency" for purposes of 12 U.S.C. § 1818(e)(7)(B)(ii), shall not:

(A) hold any office in, or participate in any manner in the conduct of the affairs of, any institution or any agency specified in 12 U.S.C. § 1818(e)(7)(A), including, but not limited to:

- (i) any insured depository institution, e.g., savings and loan associations, savings banks, national banks, state banks, trust companies, and other banking institutions;
- (ii) any institution treated as an insured bank under Sections 8(b)(3) and 8(b)(4) of the FDIA, 12 U.S.C. §§ 1818(b)(3) and 1818(b)(4), or as a savings association under Section 8(b)(9) of the FDIA, 12 U.S.C. § 1818(b)(9), e.g., subsidiaries and holding companies of banks or savings associations;
- (iii) any insured credit union under the Federal Credit Union Act, 12 U.S.C. §§ 1781 *et seq.*;
- (iv) any institution chartered under the Farm Credit Act of 1971, 12 U.S.C. §§ 2001 *et seq.*;
- (v) any appropriate Federal depository institution regulatory agency, within the meaning of 12 U.S.C. § 1818(e)(7)(A)(v); and
- (vi) the Federal Housing Finance Board and any Federal Home Loan Bank.

(B) solicit, procure, transfer, attempt to transfer, vote or attempt to vote any proxy, consent, or authorization with respect to any voting rights in any institution described in 12 U.S.C. § 1818(e)(7)(A);

(C) violate any voting agreement previously approved by the "appropriate Federal banking agency" within the meaning of 12 U.S.C. § 1813(q); or

(D) vote for a director, or serve or act as an "institution-affiliated party," as that term is defined at 12 U.S.C. § 1813(u), e.g., a director, officer, employee, controlling stockholder of, or agent for, an insured depository institution.

3. Due to the issuance of this Order, ANAMARIA PEDRAZA is a "person subject to an order in effect under subsection (e)" of 12 U.S.C. § 1818 for purposes of 12 U.S.C. § 1818(j).

4. The Stipulation is made a part hereof and is incorporated herein by this reference.

5. ANAMARIA PEDRAZA shall promptly respond to any request from the OTS for documents that the OTS reasonably requests to demonstrate compliance with this Order.

6. This Order is and shall become effective on the date it is issued, as shown in the caption hereof. This Order and the related Stipulation shall remain in effect until terminated, modified or suspended by written action of the OTS, acting through its Director, Regional Director or other authorized representative.
