OTS RELEASES MARCH ENFORCEMENT STATISTICS

WASHINGTON, D.C., June 11, 1996 -- The Office of Thrift Supervision (OTS) reported today that it completed eight enforcement actions in March 1996. This brings to 37 the number of enforcement actions by OTS since Jan. 1, 1996. Two outstanding actions also were terminated in the month.

For the month of March 1996 there were:

- 2 cease and desist orders.
- 2 civil money penalty orders.
- 2 removal and/or prohibition orders.
- 2 prompt corrective actions.
