**TERMINATION OF THE
AGREEMENT BY AND BETWEEN
CARVER FEDERAL SAVINGS BANK, NEW YORK, NEW YORK
AND THE COMPTROLLER OF THE CURRENCY**

WHEREAS, to assure the safety and soundness of Carver Federal Savings Bank, New York, New York (“Bank”) and its compliance with laws and regulations, the Bank, by and through its duly elected and acting Board of Directors, and the Office of the Comptroller of the Currency (“OCC”), through the duly authorized representative of the Comptroller of the Currency (“Comptroller”), entered into an Agreement, dated May 24, 2016, AA-NE-2016-43 (“Agreement”); and

WHEREAS, the OCC believes that the safety and soundness of the Bank and its compliance with laws and regulations does not require the continued existence of the Agreement.

NOW, THEREFORE, the OCC, through the duly authorized representative of the Comptroller, directs that the Agreement between the Bank and the OCC be, and it hereby is, TERMINATED.
